How long do I have to complete treatment?

The DUII Coordinator is required to report to the court, if you do not have treatment started within 30 days of your screening and if you do not have treatment complete within 120 days from enrollment.

You are required to contact the treatment agency to get enrolled, they will not call you.

Does insurance cover the screening/referral fee?

No. You will have to pay the \$150 fee for the screening referral. If you do not have the money you can request a payment plan.

Can you send my screening/referral to another agency?

Yes, however, we will need to verify the new agency is state certified and we will need your signature on a new release of information.

What is a 90 day no negative report?

Your chosen IID provider is required by law to report to the DUII Coordinator and the District Attorney's Office when your IID is installed and if there are negative reports. Negative reports are those that show tampering, removal of IID, or a BAC above the machine's threshold. You are required by law to have the IID installed for various lengths of time depending on whether or not you have a Diversion or a Conviction. JCCJ only supplies the courts with your installment paperwork and negative reports.

Can I have the IID removed early? (Diversion only)

Diversions are required to have the IID installed for the length of the Diversion. However, the IID requirement can be vacated if you have complied with the requirements of the Diversion for 6 months, the IID has not recorded a "negative report", and you are participating in the required treatment program.

You will need to file a motion with the court and district attorney to vacate the IID requirement.

The IID provider is required to provide a certificate to the court stating the device has not recorded a negative report.

JCCJ office does not assist in this process.

How do I get a hardship permit?

Contact your local DMV and Circuit Court for the hardship process and requirements.

You must be enrolled in a program approved by the Oregon Health Authority, you must have the IID installed in your vehicle, and the treatment agency will need to provide a recommendation to the DMV.
